### **REASONS FOR PUBLISHING IN THE MEFANET JOURNAL**

- 1. The journal has a clearly defined target group of readers teachers and experts dealing with the use of modern information technology in medical education, and in medicine in general.
- 2. A direct connection with the MEFANET network ensures a full coverage of all Czech and Slovak universities participating in the education of health professionals.
- 3. The journal has been indexed in both national and international databases. The published articles can be reported to the Register of Information on Results (RIV) within the J<sub>neimp</sub> category (this applies for authors from Czech research institutes and universities).
- 4. The professional level of the journal is ensured by an independent peer review process, which is obligatory for each article intended to be published as an "original article" or a "review".
- 5. The editors closely cooperate with authors in the process of article preparation for publication. The electronic version of the article is usually available within two weeks after the article admission for publication.
- 6. The presented results are easily available for international audience, because articles are published in English, and because the electronic version of the journal is freely available.
- 7. Supplementary information and materials (such as multimedia files, scripts, codes, etc.) can be published in the electronic version of the journal.
- 8. Apart from professional articles, popularisation and information materials (such as reports from conferences, courses and other interesting topics) can also be published in the journal.
